Application for a tenancy

The Liversage Trust is a charity mainly providing almshouses for the over 60's age group. However, the Trust also operates as a private landlord, with 38 properties let on assured shorthold tenancies. There are various sizes and types of properties available, which are detailed below, but they are all located on Nottingham Road in Derby, DE1 3QS.

- 1 x one bedroom house
- 1 x two bedroom house
- 1 x three bedroom house
- 10 x four bedroom houses
- 14 x one bedroom flats
- 11 x two bedroom flats

Anyone over the age of 18 may apply to be added to the waiting list for one of these properties, as there are no qualifying criteria. However, any offers of accommodation are subject to a successful credit check and landlord reference. If you accept an offer of accommodation from us, a deposit and the first month's rent is payable at the point of sign-up, which is also when you receive the keys for the property.

If you would like to be considered as a tenant should one of our properties become vacant, please complete this form. Please provide as much detail as you can to tell us about your current circumstances and your preferences for rehousing.
